193rd Special Operations Wing Association Scholarship Program Policy

The 193rd Special Operations Wing Association has established the 193rd SOW ASSOCIATION SCHOLARSHIP fund policy for awarding scholarships to members of the 193rd Special Operations Wing. The fund awards scholarships to current, active members of the 193rd SOW. The scholarship is an award designated to assist those members with their pursuit of civilian higher education.

Unless determined otherwise, the 193rd Special Operations Wing Association Board of Directors will appoint a Scholarship Committee which will determine selection criteria and shall select the scholarship recipients. The Committee Chair will present the proposed scholarship recipients to the 193rd Special Operations Wing Association Board of Directors for final approval.

General Guidelines:

- 1. Eligibility for the 193rd SOW ASSOCIATION SCHOLARSHIP fund is limited to current, active members of the 193rd Special Operations Wing who are enrolled or plan to enroll in a university, college, or trade school of their choice during the award period.
- 2. Scholarships awarded in the Spring Semester shall be made available to students for disbursement in the following Fall Semester. Scholarship recipients must display verification of registration in courses.
- 3. The 193rd Special Operations Wing Association intends, congruent with applicable funding, to offer one scholarship award annually.
- 4. The 193rd SOW ASSOCIATION SCHOLARSHIP Fund will award the recipient with \$500.00 for use in pursuit of academic degrees or trade certification.
- 5. The 193rd Special Operations Wing members who have been awarded a scholarship may claim their funds 30 days after the date awarded and utilize these funds within two years of receiving funds. A scholarship or funded student account that is unclaimed after two years shall lapse and the awarded funds shall be returned to the 193rd SOW ASSOCIATION SCHOLARSHIP fund. However, funds may be reappropriated by the Board of Directors if funds are available and if the recipient provides evidence of the circumstances that prevented claiming or utilizing the award within the two-year period i.e. extended deployments or illness.

Award Criteria for Eligible Members:

- 1. Members must submit a 500-700 word essay on one of the following two questions.
 - A. How will higher education/technical training aid you in serving the 193rd Special Operations Wing and the community? Explain.
 - B. Do you believe that the pursuit of higher education/technical training will aid you in applying the U.S Air Force Core Values of Integrity First, Service Before Self, and Excellence? If so, how?
- 2. Members seeking the award must submit the essay along with one letter or recommendation.
- 3. Members seeking the award must submit their package to the 193rd Special Operations Wing Association prior to the end of the Fall Semester or December 1st for new students.

Deadline for applying for this fall is July 30th.
