In Honor of Coronet Solo

The Association just completed another phase of the static display of aircraft A-7773 an EC-130E with the addition of a memorial bench in front of the aircraft, located in the Air Park at Fort Indiantown Gap. The Bench honors Navy Captain George Dixon the Father of Coronet Solo. In early 1964 retired Navy Captain George Dixon was called back from retirement to oversee project Jenny, after he convinced the navy they needed a platform to broadcast radio and television for both entertainment and psychological warfare. The NC-121-J Super Constellation was the aircraft configured for the mission. Later in the 60's the

Navy dropped the program and it was picked up by the Air National Guard and the 193rd who were already flying the 121's. The unit renamed the 193rd Tactical Electronic Warfare Group. The 193rd kept the mission as it converted to EC-130E's in the 80's and then later to the EC-130J's. It's name and parent organization also changed as it evolved into the 193rd Special Operations Wing.



Colonel Benjamin (Mike) Cason is the wing commander of the 193rd Special Operations Wing, Pennsylvania Air National Guard, Middletown, Pennsylvania. Col Cason is responsible for the training and readiness of approximately 1,900 combat-ready Airmen and several EC-130J aircraft, which provide Military Information Support Operations, Electronic Attack, and Special Operations Forces Mobility in support of U.S. Special Operations Command. The wing also includes eight geographically separated units organized in a unique Regional Support Group that provides various expeditionary combat support capabilities to the U.S. Air Force, Air Combat Command, and Air Force Space Command, the National Guard Bureau and the Commonwealth of Pennsylvania. Approval to serve in this capacity must come from the Secretary of Defense and the governor, a process that takes several months to vet. Col Cason first joined the 193rd SOW in August 2013 as a dual-status vice wing commander.

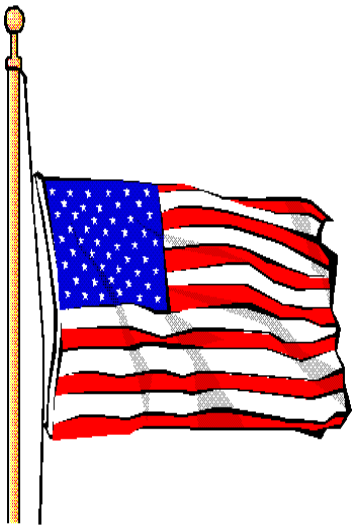
