The 193d SOW Enlisted Council wishes to thank the members of the Association for their assistance in making their **Wreaths Across America** Program another successful year. This year we assisted Indiantown Gap National Cemetery placing a

wreath on every grave. We sponsored 187 wreaths this year.

Then on December 17th a group of unit members laid a wreath on the graves of the 83 known departed unit member interred at the National Cemetery. The 201st RHS Alumni also placed wreaths on their 32 deceased unit members the day before. We would welcome the assistance of the Association members in placing these wreaths next year.

2022 193rd SOW Association Scholarship Program

The 193rd Special Operations Wing Association Scholarship is an annual program that gives a \$1,000 award directly to a wing member or members it feels demonstrates outstanding leadership potential. This will be the seventh year for the scholarship program and the association is looking forward to receiving many qualified submissions. The Association will be awarding at least one THOUSAND dollar prize. The 2022 Scholarship program will open June 1, 2022 and close July 31, 2022. The requirement for the scholarship this year will be a 300-500 word essay in your own words on the following topic: **Due to the challenges created by COVID, over the last year and a half, many innovations in processes and programs have been developed. Some of these innovations may prove to be beneficial not just now but into the future, beyond COVID. Describe at least 3 of these innovations you have experienced and explain why you believe they may be beneficial for future generations.** The paper should be double-spaced, grammatically correct and not exceed 500 words. If the paper does not meet the requirements specified it will not be considered for the scholarship!

Board of Directors Recommended Changes to the Association By-laws

The Board has completed the biennial review of the Association's Bylaws. Very few changes were noted and all were minor or grammatical in nature. Here are the proposed changes:

Article II Purpose and Mission, section 2.01 C - change the wording from "men and women" to "members"

Article VI Directors, section 6.03 Additional Powers- change the wording of the 1st sentence from "In addition to the powers and authority **by** these by-laws" to "In addition to the powers and authority **of** these by-laws"

Article VI Directors, Section 6.10 Fiduciary Relationship- add "or her" to the first sentence after the word "his" where stated "...shall perform his duties as Director, including his duties as a member of any committee..." and in (C) add "or she" where stated "A committee of the Board upon which he does not serve..."

Article X Membership Certification, Section 10.01– add "**If provided**," to the beginning of the last sentence where stated "They shall be signed by the President or Vice President..."

Article XII Annual Report, Section 12.01- change "annually" to "at the annual meeting" in the first sentence. To read "The Board of Directors shall present at the annual meeting.... the following:"

Article XIII Notices, Section 13-01 Manner of Notice- add "or by email" and "or her" to the 1st sentence to now read "Whenever written notice is required to be given to any person, it may be given to such person, either personally; by sending a copy thereof by first class mail, postage prepaid; by telegram, charges prepaid; or by email to his or her address appearing on the books of the corporation or, in the case of Directors, supplied by him or her to the corporation for the purpose of the notice. And add "email" to the 2nd sentence to now read "If the notice is sent by mail, email or telegraph, it shall be deemed to have been given to the person …"

Article XVII Dissolution, Section 17-01— add "This Article is also part of our Articles of Incorporation filed with the PA Dept of State." To the end of the paragraph.

These changes will need to be approved by the general membership at our annual meeting in April.



Foundation

The 193rd Special Operations Wing Association is a qualifying federally recognized 501 (c)3 (nonprofit organization) and we have linked up with the Amazon.com organization to allow anyone making qualifying internet purchases to have a donation made to our organization at no cost to them.
