### New Lickdale Veterans' Outreach Center First of Its Kind One-Stop-Shop for Veterans and Their Families



The Lickdale Veterans' Outreach Center, <u>Lickdale Veterans'</u> Outreach Center - which opened to the public on June 3, is the first of several planned regional outreach centers that reflect the Shapiro Administration's forward-thinking approach to serving the nearly 700,000 veterans across the Commonwealth - the fifth largest veteran population in the nation - including more than 80,000 veterans in Lebanon County and the surrounding counties of Dauphin, Berks, Lancaster, and Schuylkill.

"Our veterans have sacrificed for us, serving our nation to defend our freedoms - and they deserve a Commonwealth that cares for

and invests in them," said **Governor Shapiro**. "It's an honor to be here today to cut the ribbon on Pennsylvania's first in-person veterans' resource center and open new doors on this one-stop-shop for the brave men and women who have served our Commonwealth and our country. We owe our veterans more than just our gratitude - we owe them real support and that's why my Administration is making it easier than ever for veterans and their families to access the care, benefits, and services they've earned."

The Lickdale Center provides in-person access to accredited veteran service officers who assist with navigating and applying for military benefits. It also includes state-of-the-art conference rooms, private meeting areas, and training spaces for advocacy groups and service organizations. The center is open to the public Monday through Friday, from 8:00 AM to 4:00 PM.

This is more than just a building - it's a commitment to the men and women who have served our country," said **Adjutant General Pippy**. "By bringing together federal, state, and community partners in one space, we can help veterans address complex challenges and connect to the benefits they've earned through their service."

The center also includes increased privacy, improved access to DMVA staff, and a welcoming, community-focused environment. In addition to DMVA service officers, organizations like CareerLink will be stationed on-site to offer additional support. In addition to accredited veterans service officers from DMVA, community-based advocacy groups like CareerLink will also be stationed on-site to support veterans.

With recent federal changes to veterans' benefits — including the **Promise to Address Comprehensive Toxics (PACT) Act** - many veterans are revisiting their eligibility and require additional assistance. Veterans are encouraged to bring military paperwork, such as a **DD-214**, though staff can also help locate missing documents.

### **REAL ID and Next Gen ID Card**



Passed by Congress in 2005, the REAL ID Act was enacted in response to the recommendations of the 9/11 Commission to improve national security. The goal of the REAL ID Act is to prevent identity fraud by establishing minimum security standards for state-issued driver's licenses and identification cards. The Department of Homeland Security started Real ID Act enforcement on 7 May 2025. This affects what forms of documentation can be used to access certain federal facilities, military installations, and to board domestic commercial flights. You can check your state's compliance on the Department of Homeland Security website https://www.dhs.gov/real-id

Eventually, you will need to have the NextGen ID card because the old forms of ID will not be valid to access military installations; this will be true even if your old ID card has an INDEF expiration date on it.

Military retirees, dependents, and surviving spouses who already possess military, or DoD issued credentials, will still be granted installation access for the foreseeable future even if you have an "old style" ID card (DD Form 2, DD Form 1173, DD Form 1173-1 or DD Form 2765 (blue, pink or tan ID)). DoD will formally announce when a date has been set.



There are several ways to make an appointment to get a new ID card. You can visit the RAPIDS ID Card Office Locator website to find the closest office and either call them to make an appointment or schedule your own appointment using the website <a href="https://idco.dmdc.osd.mil/idco/">https://idco.dmdc.osd.mil/idco/</a> (will transition to myAuth as of 20 May 2025). To make an appointment using this site select the "ID Card Office Locator & Appointments" block. You may also be able to renew your ID card online and have it mailed to you. Select the "Family ID Cards" block on the website at the link above. Below are the requirements to renew a card online:

- Sponsor must be a CAC holder or have a DoD Self-Service Logon username/password
- Must be requesting a renewal of an active USID card
- Sponsor and cardholder must have email addresses listed in the Defense Enrollment Eligibility Reporting System (DEERS) that they have authorized DoD to use for contacting them
- Sponsor's personnel status must extend at least 30 days into the future
- Cardholder has a photo saved in DEERS taken in the last 12 years
- Cardholder's mailing address is present in DEERS and is in United States or Overseas.
- USID cards cannot be shipped to PO Boxes

All old-style ID card holders are encouraged to get a NextGen ID card soon!


